
We have two former and current Morrow County commissioners that are under ethics violations and one is under a Oregon Department of Justice investigation.

We have six of the seven Boardman city councilors that have ethics violations and pleaded guilty to them.


Corruption and conflict of interest is rampant and needs to be called out.
