HOW TO SPEND YOUR NEXT BIRTHDAY IN PRISON



IF YOU ARE 15
OR OLDER
OR ALMOST 15
.....READ ON

1. **Get in a fight (even if both parties agree to fight, and cause serious physical-injury (protracted or permanent loss of a limb or organ) i.e.: broken jaw, arm, etc.**

CHARGE ASSAULT II

MINIMUM SENTENCE: 5 yrs 10 mos
(no early release or parole)

2. **Same fight – cause serious physical injury by use of a dangerous weapon (club, knife, boots, etc.)**

CHARGE ASSAULT I

MINIMUM SENTENCE: 7 yrs 6 mos
(no early release or parole)

3. **Drive Drunk – kill a friend – or someone else**

CHARGE MANSLAUGHTER I

MINIMUM SENTENCE: 10 yrs
(no early release or parole)

4. **Drive Drunk – injure someone**

CHARGE ASSAULT II

MINIMUM SENTENCE: 5 yrs 10 mos
(no early release or parole)

5. **Have sexual relations with someone under 18 and more than 3 years younger than yourself (even if both parties consent)**

CHARGE RAPE II

MINIMUM SENTENCE: 6 yrs 3 mos
(no early release or parole)

6. **A 15-year-old touches the sexual or other intimate part of a 12-year-old (consent is not a defense)**

CHARGE SEXUAL ABUSE I

MINIMUM SENTENCE: 6 yrs 3 mos
(no early release or parole)

7. **Two persons commit or attempt to commit theft by use or threatened use of physical force**

CHARGE ROBBERY II

MINIMUM SENTENCE: 5 yrs 10 mos
(no early release or parole)

Believe it or not, what you have just read is true. In November of 1994, the citizens of Oregon passed Ballot Measure 11, which sets mandatory minimum sentences for certain felony crimes. Youth 14 years of age and older who commit those crimes are subject to prosecution in the adult criminal courts, and upon conviction, will be given the mandatory minimum sentences. The law went into effect April 1, 1995.

The examples which you have just read constitute only a few of the crimes which carry mandatory minimum sentences under this law. We at the Morrow County Juvenile Department are invested in your success as a member of your community.

We want you to be informed, and to subsequently choose your steps and course of conduct wisely to avoid entrance into a system with its new and harsh consequences.

On the back of this brochure you will find a listing of all offenses subject to the sentencing guidelines of Ballot Measure 11, and the mandatory minimum sentences. All of the listed crimes apply to youth 15 years and older. *Those crimes marked with an asterisk apply to youth 14 years of age and older.
