COUNTY ORDINANCE NO. MAC-3-83

WHEREAS, the Land Conservation and Development Commission, upon the initial review of the Morrow County Comprehensive Plan, found minor deficiencies in Goals 2, 3, 4, 5, 6, and 12, it was returned for corrections; and

WHEREAS, Morrow County has diligently worked towards amending the plan in the face of continually changing rules and regulations since July 1981; and

WHEREAS, the Morrow County Planning Commission, in conjunction with its cities and duly appointed Citizen Involvement Committees, has held four (4) workshops and two (2) public hearings and recommended changes toward meeting Land Conservation and Development Commission requirements to the subject land use plan; and

WHEREAS, the Morrow County Court has conducted a public hearing on the subject amendments to the comprehensive plan; and

WHEREAS, the adoption of such plan amendments is deemed necessary to achieve orderly and efficient growth of the county and to meet the requests of the Land Conservation and Development Commission of the State of Oregon towards approval of the Morrow County Comprehensive Plan.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COURT OF THE COUNTY OF MORROW, that the amendment to the Comprehensive Plan of 1980 for the County of Morrow be hereby adopted.


ENACTMENT, EMERGENCY DECLARED. An emergency is hereby declared and this ordinance shall be and is hereby declared to be in full force and effect on and after the date of its approval by the County Court.
