ORDINANCE NUMBER MC-C-3-99

The County of Morrow does ordain as follows;

WHEREAS, the Morrow County Planning Commission reviewed the combined Conditional Use Permit and Comprehensive Plan Amendment application filed by the Oregon Department of Transportation, to establish a new quarry site in the Jones Hill area along State Highway 74; and

WHEREAS, the Morrow County Planning Commission held public hearings on January 11, 1999 at Irrigon, Oregon and February 22, 1999 at Lexington, Oregon;

WHEREAS, the Morrow County Planning Commission voted unanimously to approve the Conditional Use Permit to operate a rock crusher and asphaltic concrete batch plant, and to amend the comprehensive plan to include the site on the Goal 5 aggregate inventory; and

WHEREAS, the Morrow County Court reviewed the recommendation for approval by the Morrow County Planning Commission and voted unanimously to uphold the decision of the Planning Commission; and

WHEREAS, the Morrow County Court held a public hearing on March 3, 1999 at Heppner, Oregon.

NOW THEREFORE, THE COUNTY COURT OF MORROW COUNTY ORDAINS AS FOLLOWS:

SECTION 1. TITLE OF ORDINANCE.

This ordinance shall be known, and may be cited as, "the Comprehensive Plan Goal 5 Amendment for the ODOT/Jones Hill Aggregate Site"

SECTION 2. TEXT AMENDMENT.

Amend page 102 of Comprehensive Plan to include:
"ODOT/Jones Hill Pit" located on tax lot 1700 of Assessor's
Map 2S 28, a 7.5 acre parcel.

SECTION 3. EFFECTIVE DATE.

This ordinance shall become effective 90 days after the date
of its adoption by the Morrow County Court.
