ORDINANCE NUMBER MC-C-6-97

The County of Morrow does ordain as follows;

WHEREAS, the Morrow County Planning Commission reviewed the combined Conditional Use Permit and Comprehensive Plan Amendment application filed by the Miller & Sons Excavating, to establish a new quarry site in the Heppner area; and

WHEREAS, the Morrow County Planning Commission held public hearings on June 30, 1997 at Irrigon, Oregon and July 28, 1997 at Lexington, Oregon;

WHEREAS, the Morrow County Planning Commission voted to approve the Conditional Use Permit to operate the County rock crusher and to recommend County Court approve the comprehensive Plan Amendment to include the site on the Goal 5 aggregate inventory; and

WHEREAS, the Morrow County Court reviewed the recommendation for approval by the Morrow County Planning Commission and voted unanimously to uphold the recommendation of the Planning Commission to add the quarry to the Aggregate Resources Inventory of the Comprehensive Plan; and

WHEREAS, the Morrow County Court held a public hearing on August 6, 1997 at Heppner, Oregon.

NOW THEREFORE, THE COUNTY COURT OF MORROW COUNTY ORDAINS AS FOLLOWS:

SECTION 1. TITLE OF ORDINANCE.

This ordinance shall be known, and may be cited as, "the Comprehensive Plan Goal 5 Amendment for the Turner Aggregate Site"

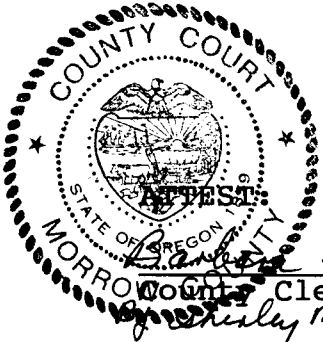
SECTION 2. TEXT AMENDMENT.

Amend Page 102 of the Comprehensive Plan to add: "Turner Pit" to the Aggregate Resources Inventory.

SECTION 3. EFFECTIVE DATE.

An Emergency Clause shall be recognized since the applicant is in urgent need of rock resource and construction projects are pending. This ordinance shall become immediately upon adoption by the Morrow County Court.
