ORDINANCE NUMBER MC-C-8-98

The County of Morrow does ordain as follows;

WHEREAS, the Morrow County Planning Department obtained a grant from the State of Oregon Transportation and Growth Management Program to develop a county-wide Transportation System Plan (TSP); and

WHEREAS, the County Court appointed a Technical Advisory Committee, representing varied transportation interests in the county, to work with staff and a consultant to develop a comprehensive transportation plan for the county; and

WHEREAS, the Morrow County Planning Commission reviewed the Transportation System Plan with staff and heard a presentation by the consultants on the contents of the TSP.

WHEREAS, the Morrow County Planning Commission voted unanimously to accept the Transportation System Plan and adopt changes to the Comprehensive Plan, Zoning Ordinance and Subdivision Ordinance as recommended in the TSP; and

WHEREAS, the Morrow County Planning Commission held public hearings on May 26, 1998 at Lexington, Oregon and June 26, 1998 at Irrigon, Oregon and July 27, 1998 at Lexington, Oregon and August 31, 1998 at Irrigon, Oregon; and

WHEREAS, the Morrow County Planning Commission voted unanimously to accept the Transportation System Plan and amend the Comprehensive Plan, Zoning Ordinance and Subdivision Ordinance as recommended in the TSP; and

WHEREAS, the Morrow County Court held a public hearing on September 16, 1998 at Boardman, Oregon.

NOW THEREFORE, THE COUNTY COURT OF MORROW COUNTY ORDAINS AS FOLLOWS:

SECTION 1. TITLE OF ORDINANCE.

This ordinance shall be known, and may be cited as, "The Morrow County Transportation System Plan Ordinance."

SECTION 2. TEXT AMENDMENT.

See attached document entitled Morrow County Transportation System Plan.

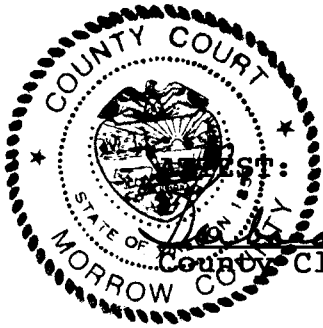
SECTION 3. EFFECTIVE DATE.
