TO EXCLUSIVE FARM USE ON A 318 ACRE PARCEL)	

WHEREAS, ORS 203.035 authorizes Morrow County to exercise authority within the County over matters of County concern; and

WHEREAS, Morrow County adopted a Comprehensive Land Use Plan which was first acknowledged by the Land Conservation and Development Commission on January 15, 1986; and

WHEREAS, the Morrow County Planning Department accepted an application from Threemile Canyon Farms on December 20, 2023; and

WHEREAS, the Morrow County Planning Department deemed the application from Threemile Canyon Farms complete on December 26, 2023; and

WHEREAS, the Morrow County Planning Commission held a public hearing on January 30, 2024 and voted unanimously to recommend the Board of Commissioners approve the application; and

WHEREAS, the Morrow County Board of Commissioners held a public hearing on February 21, 2024 and voted to approve the application; and

WHEREAS, the Morrow County Board of Commissioners held a public hearing on March 6, 2024 and conducted a second reading of the ordinance.

NOW THEREFORE THE MORROW COUNTY BOARD OF COMMISSIONERS ORDAINS AS FOLLOWS THAT THE MORROW COUNTY BOARD OF COMMISSIONERS AMENDS THE COMPREHENSIVE PLAN TO CHANGE THE COMPREHENSIVE PLAN MAP AND ZONING MAP OF A 318 ACRE PARCEL OF LAND FROM SPACE AGE INDUSTRIAL TO EXCLUSIVE FARM USE.

Section 1 Title of Ordinance:

This Ordinance shall be known, and may be cited, as the “2024 Threemile Canyon Farms Plan Map and Zone Map Amendment.”
