

MAP OF SURVEY

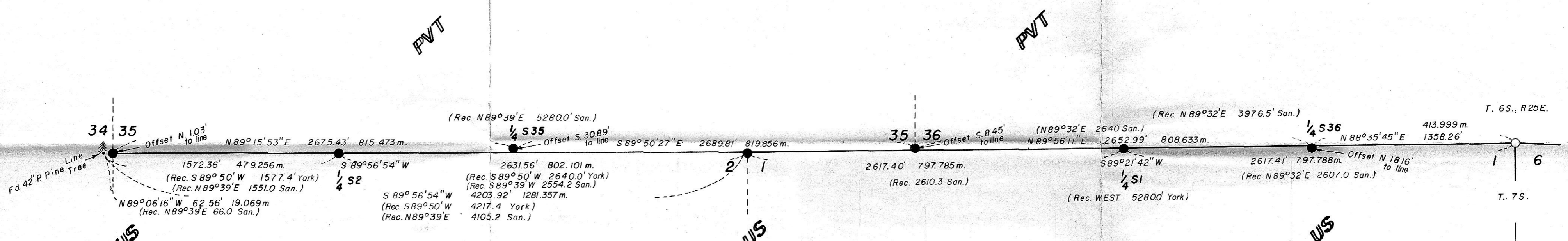
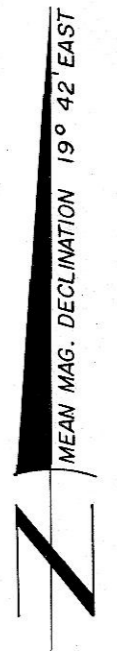
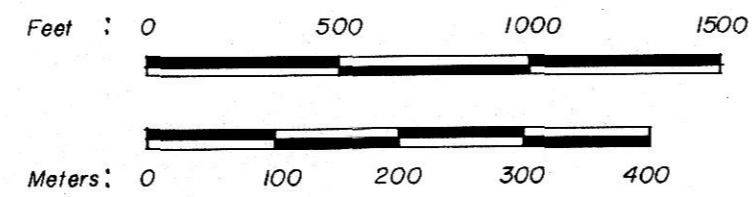

HISTORY
 Township 7 South, Range 25 and 26 East were surveyed and subdivided by Aaron F. York under G.L.O. contract No. 309 date 1878. Township 6 South, Ranges 25 and 26 East were surveyed and subdivided by E.W. Sanderson under G.L.O. contract No. 368 dated 1880. Sanderson retraced the North boundary of Township 7 South, Ranges 25 and 26 East during the performance of his survey. Sanderson set corners common to those sections in Township 6 South only. See the accompanying narrative for further information.

PROCEDURE
 All controlling corners were encompassed in a series of closed traverses made with a Wild T-2 theodolite and an H.P. 3805 A E.D.M. The two proportioned quarter corners were set only after extensive search in the vicinities failed to yield original evidence. The original P Pine Line Tree to the west; found mound of stone at section corner of 2 & 1; and Township corner of Township 7 South, Ranges 25 and 26 East were held for control.
