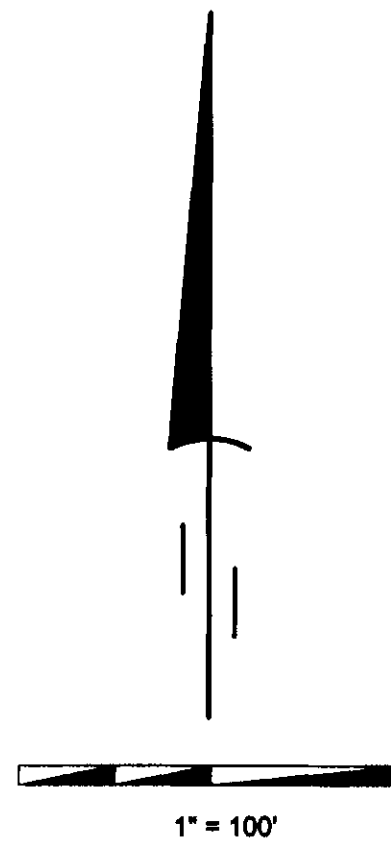
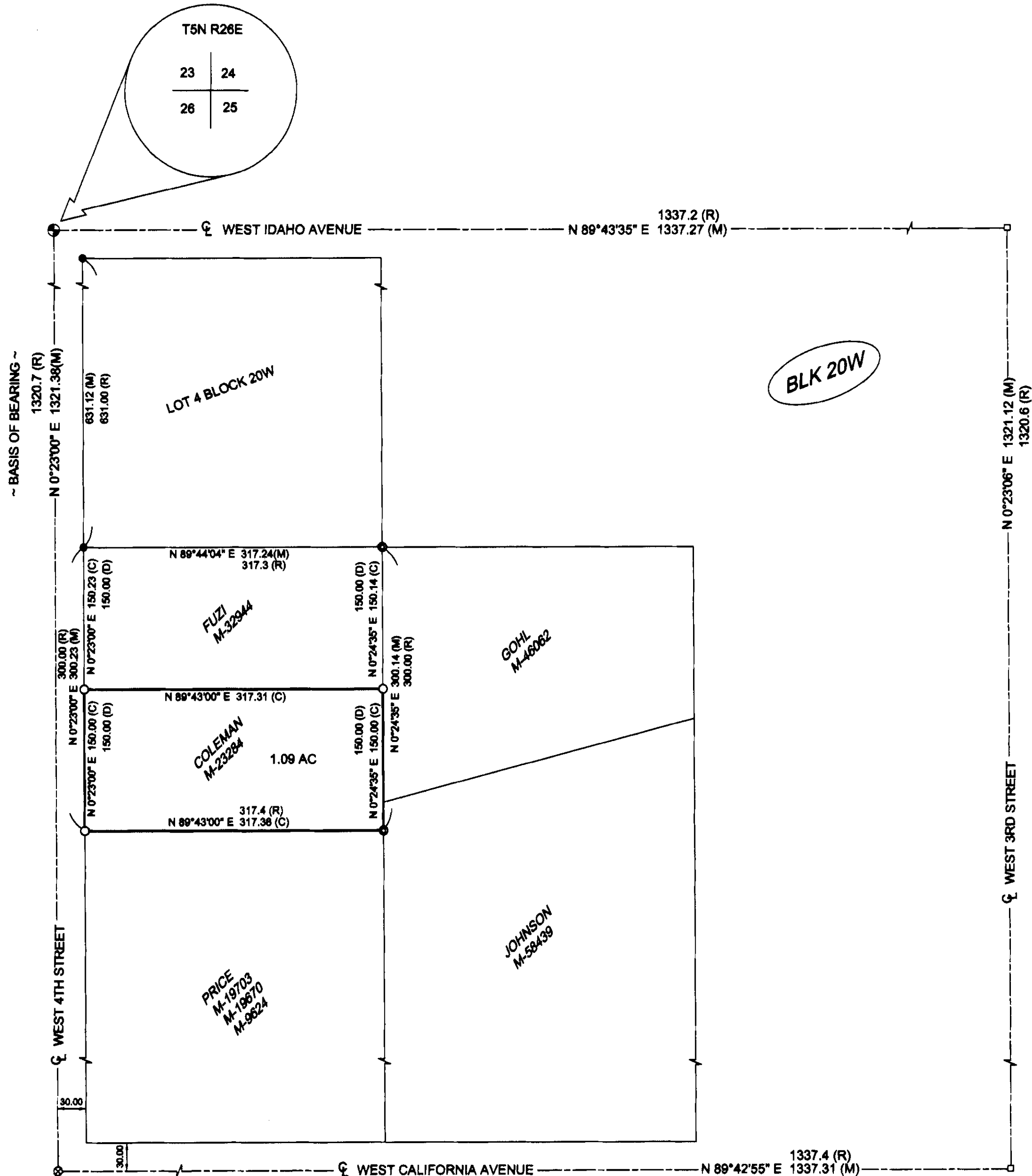


# RECORD OF SURVEY

## SURVEYOR'S NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF KAREN COLEMAN TO MONUMENT THE SOUTH 150 FEET OF THE NORTH 300 FEET OF LOT 5 BLOCK 20W.

WALTER W. CRAMER SET THE FOUR LOT CORNERS OF LOT 5 BLOCK 20W IN 1981 FOR JOHN B. COLEMAN. OF WHICH I RECOVERED THE NORTHEAST AND THE SOUTHEAST CORNERS OF SAID LOT, I ALSO RECOVERED THE NORTHWEST AND THE SOUTHWEST CORNERS OF LOT 4 BLOCK 20W SET BY TOMPKINS SURVEYING. THE FOUR BLOCK CORNERS OF BLOCK 20W WERE RECOVERED AND THE BASIS OF BEARING FOR THIS SURVEY IS THE CENTER LINE OF WEST 4TH STREET.
