Harris, being first duly sworn, depose and say: That I correctly surveyed and marked with proper monuments as indicated on the accompanying Plat of SOUTH BOARDMAN in Morrow County, Oregon, the lands indicate thereupon, that the initial point of this survey is a 6"x36" Concrete Monument set 6" below the surface of the ground, said point being S 89°17'38" East, a distance of 860.48' from the S.W. Cor. of Sec. 9, T4N, R25E., W.M., that the exterior boundaries of the land hereby platted are as follows:

Beginning of the above described initial point and running thence S 89°17'38"E - 650.00'; thence N 7°35'W - 339.50'; thence N 69°49'25"E - 301.18'; thence N 7°35'W - 419.70 to a point on the Southerly R/W line of relocated Highway 80N; thence S 69°49'25", along said R/W, 600.00'; thence N 87°19'10"W, along said R/W, 600.00'; thence S 7°35'E - 440.00'; thence S 82°05'52"E - 242.70'; thence S 7°35'E - 223.99 to the point of beginning.

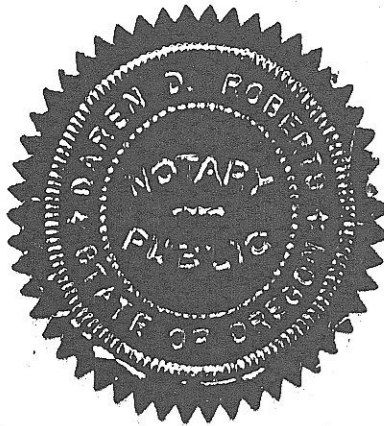
