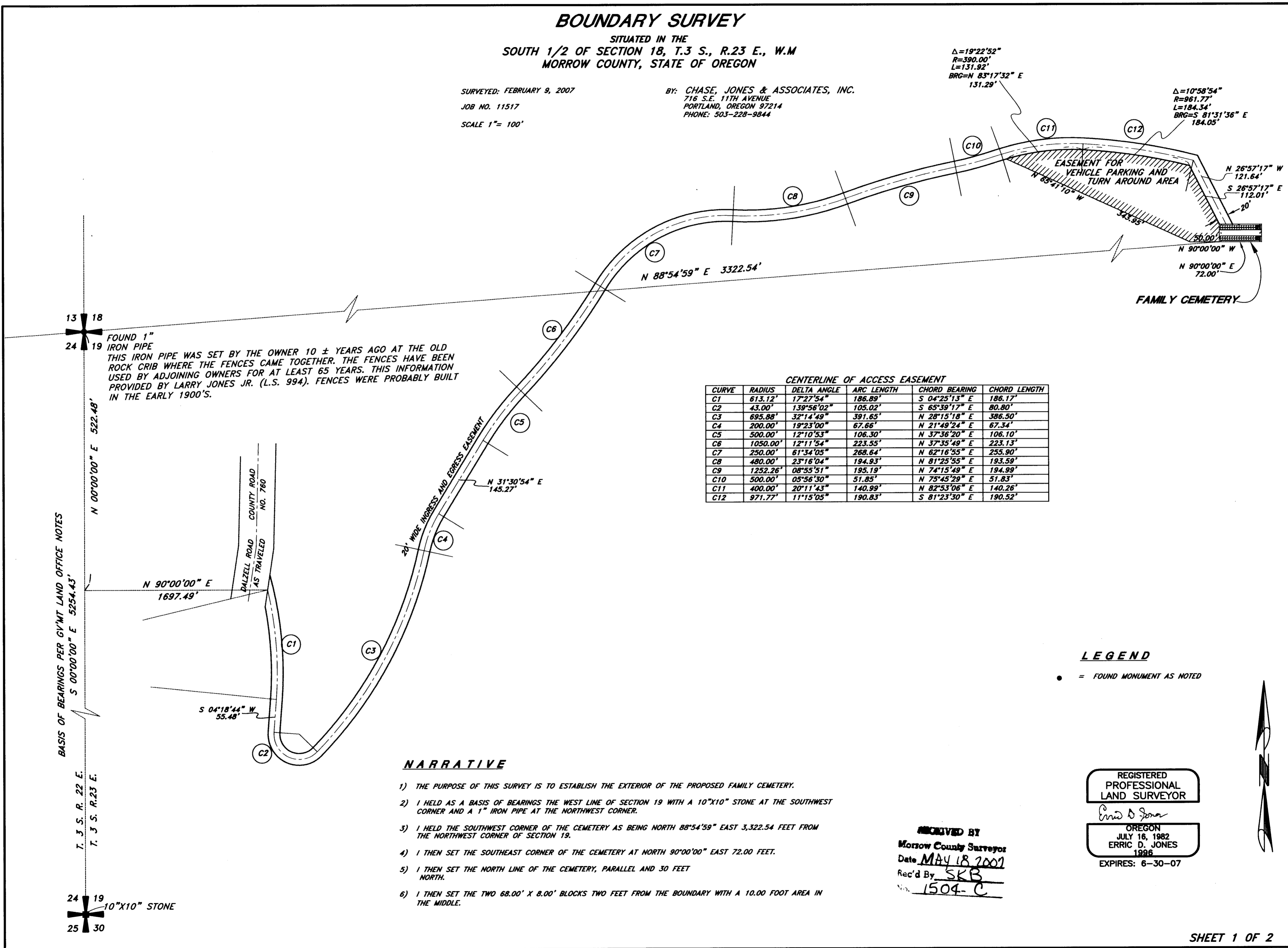

### NARRATIVE

- 1) THE PURPOSE OF THIS SURVEY IS TO ESTABLISH THE EXTERIOR OF THE PROPOSED FAMILY CEMETERY.
- 2) I HELD AS A BASIS OF BEARINGS THE WEST LINE OF SECTION 19 WITH A 10"X10" STONE AT THE SOUTHWEST CORNER AND A 1" IRON PIPE AT THE NORTHWEST CORNER.
- 3) I HELD THE SOUTHWEST CORNER OF THE CEMETERY AS BEING NORTH 88°54'59" EAST 3,322.54 FEET FROM THE NORTHWEST CORNER OF SECTION 19.
- 4) I THEN SET THE SOUTHEAST CORNER OF THE CEMETERY AT NORTH 90°00'00" EAST 72.00 FEET.
- 5) I THEN SET THE NORTH LINE OF THE CEMETERY, PARALLEL AND 30 FEET NORTH.
- 6) I THEN SET THE TWO 68.00' X 8.00' BLOCKS TWO FEET FROM THE BOUNDARY WITH A 10.00 FOOT AREA IN THE MIDDLE.

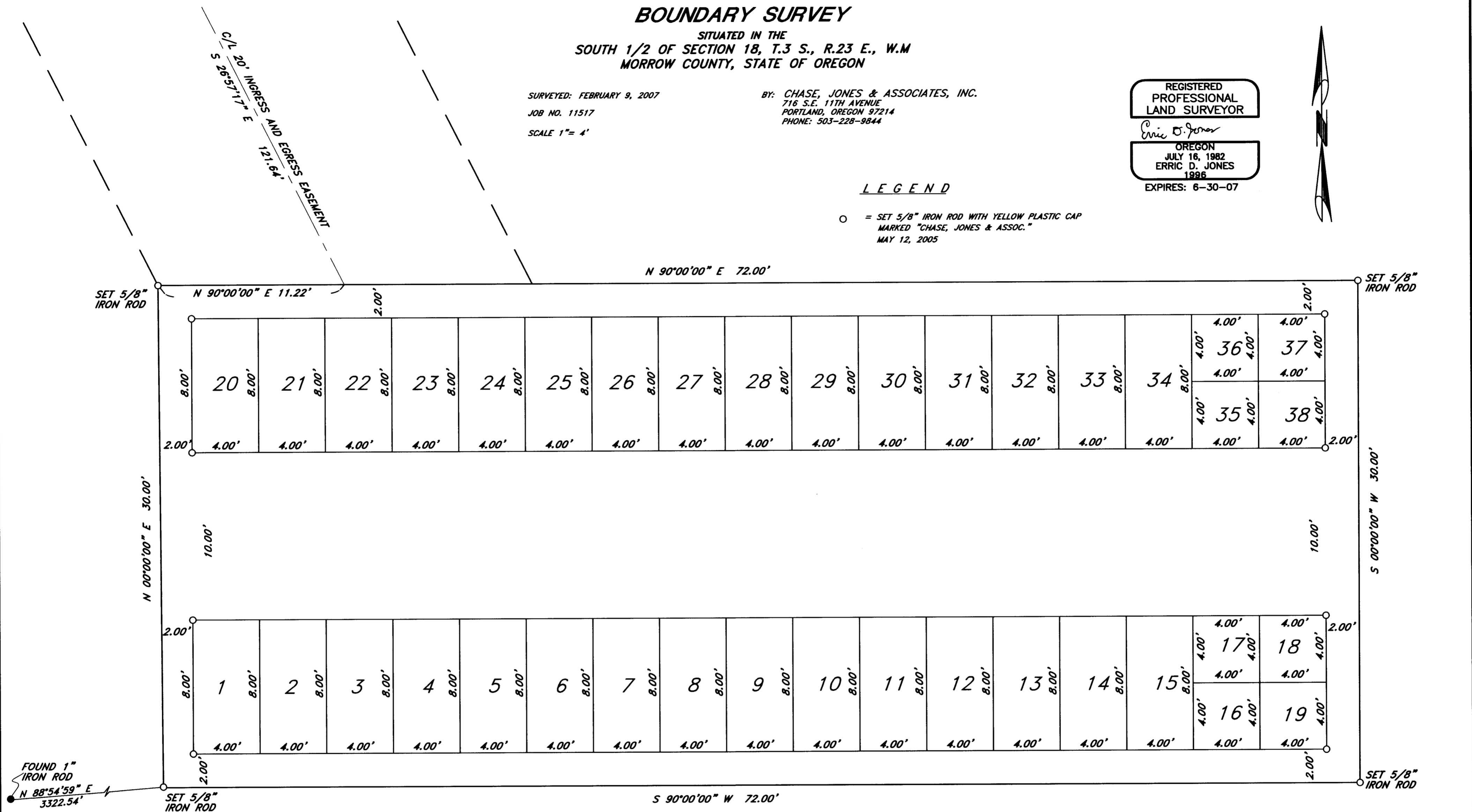
