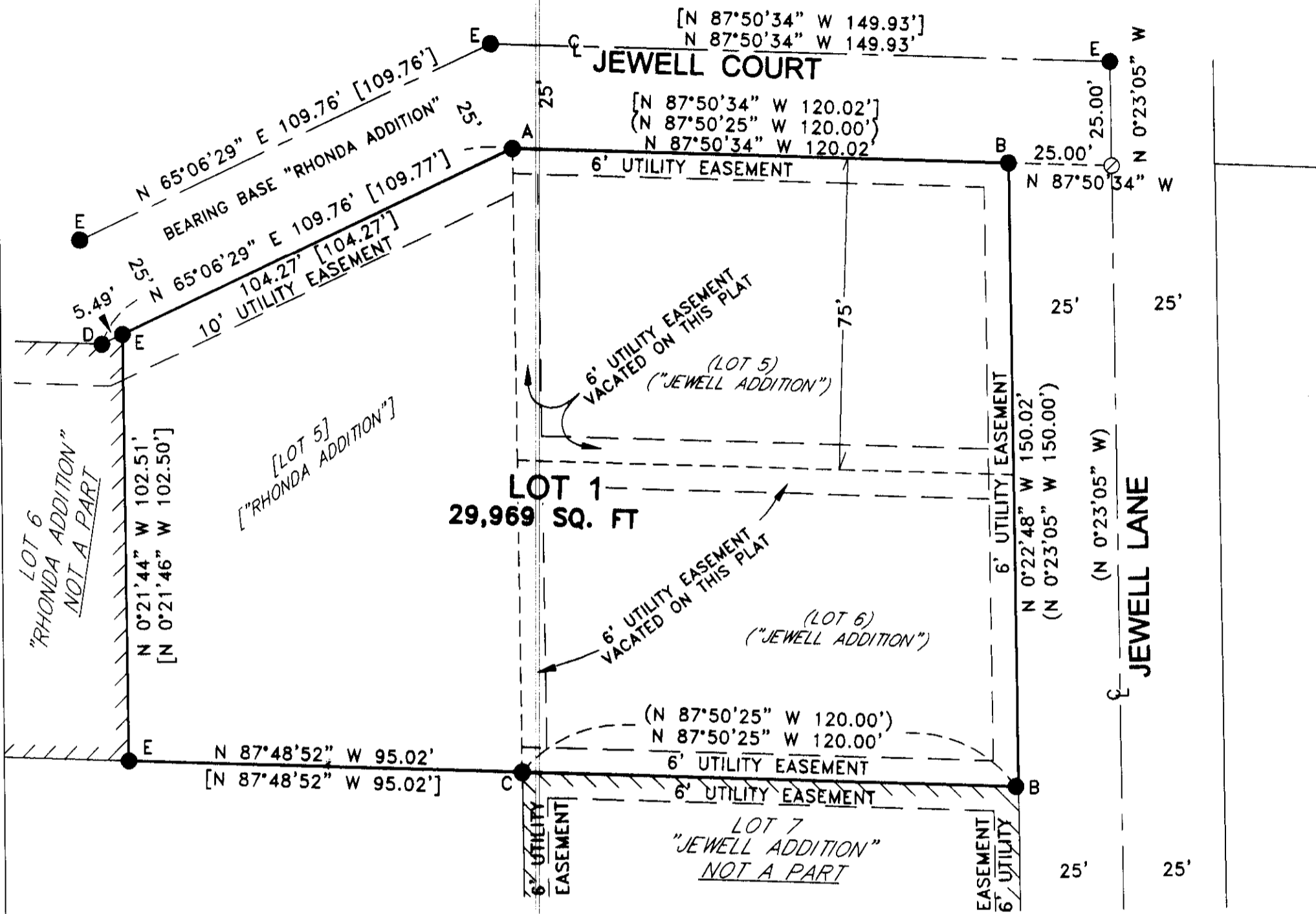


"SORENSEN REPLAT"
