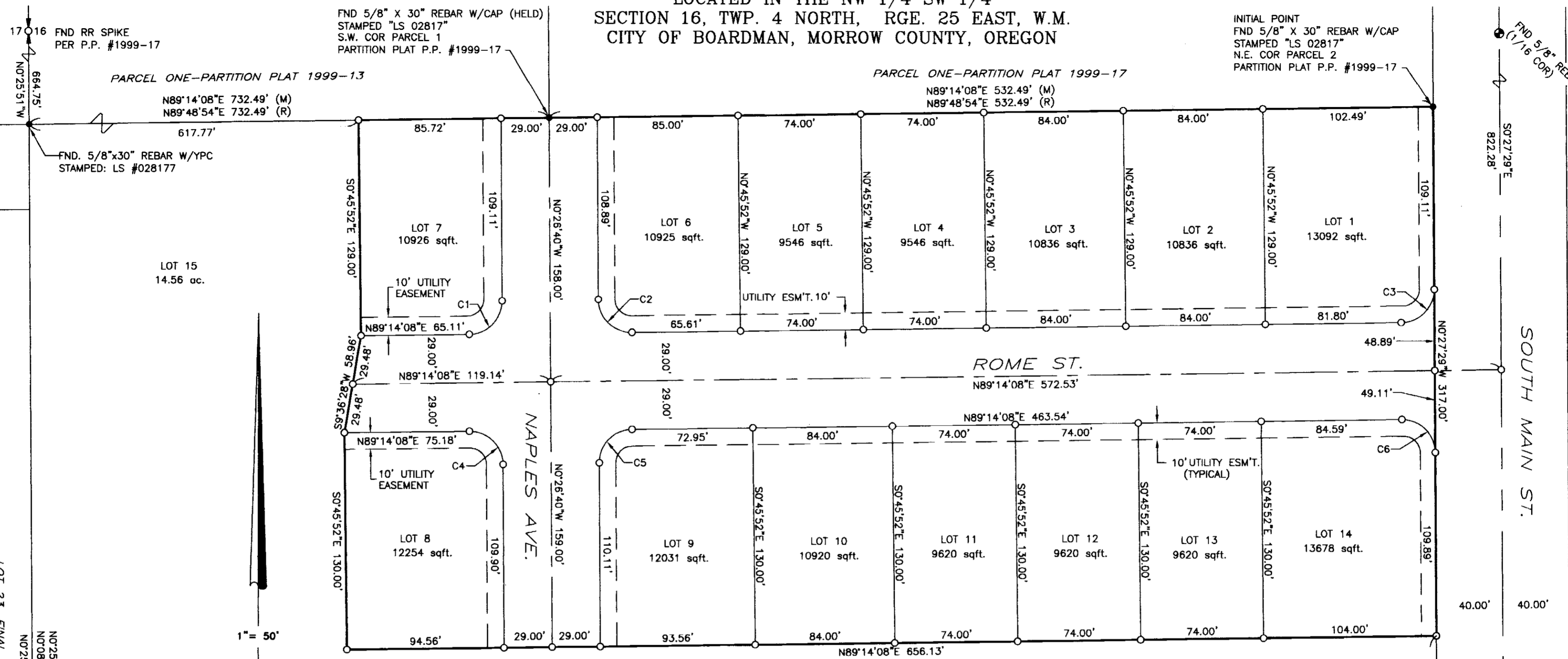


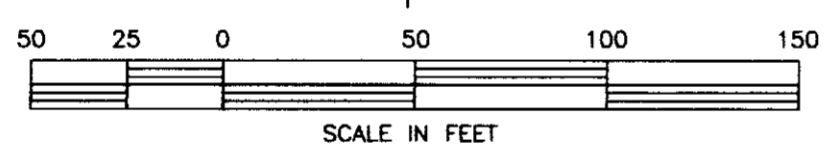
PLAT OF TUSCANY AT BOARDMAN

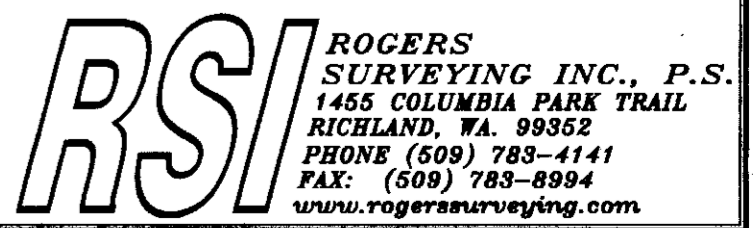

SURVEYOR'S NARRATIVE

BASIS OF BEARING FOR THIS SURVEY IS THE OREGON COORDINATE SYSTEM (NORTH ZONE) NAD_83 (2011). DISTANCES ARE TRUE GROUND MEASUREMENTS SCALED FROM GRID. EXISTING MONUMENTS MARKING THE THE SOUTHERLY BOUNDARY OF PARCELS ONE AND TWO OF PARTITION PLAT 1999-17 WERE FOUND AND HELD FOR THE NORTH LINE OF THIS SUBDIVISION. THE WESTERLY, SOUTHERLY AND EASTERLY LINES OF THE SUBDIVISION WERE ESTABLISHED FROM THE SECTION BREAKDOWN OF THE SOUTHWEST QUARTER OF SECTION 16 AS SHOWN ON PARTITION PLAT NO. 1999-17.

THE PRIMARY CONTROL FOR THIS SURVEY WAS PERFORMED UTILIZING TRIMBLE R8-3 GPS RECEIVERS CONFIGURED FOR REAL TIME KINEMATIC SURVEYING. ALL CONTROLLING CORNERS WERE VISITED IN JANUARY 2014.
