PARCEL 2 IS SURVEYED. TO ESTABLISH THE EAST LINE OF PARCEL 2 I HELD AND FOUND THE MONUMENTS AS SHOWN ALONG THE EAST LINE OF SECTION 12. THE REMAINING PARTITION LINES ARE FREE LINES AS DESIRED BY THE CLIENT. THOSE PORTIONS OF RUPE KENNEDY ROAD RIGHT OF WAY LOCATED IN SECTION 12 ARE TO BE DEDICATED AS SHOWN. THIS SURVEY WAS PERFORMED USING A TRIMBLE R12 GPS SYSTEM IN RTK MODE.
