THE PURPOSE OF THIS SURVEY WAS TO ESTABLISH THE OUTER BOUNDARY OF PARCEL 2 OF PARTITION PLAT NO. 2022-16, FILE NUMBER 2005 OF MORROW COUNTY SURVEY RECORDS.

THE NORTH LINE OF SAID PARCEL 2 WAS ESTABLISHED BY HOLDING THE FOUND MONUMENTS PER SAID PARTITION PLAT.
